The **Closing Date** for Resolutions is **30th November 2018** and they **must** be received on or before that date. It is the responsibility of the Club submitting a resolution to ensure that the same has been received. It is usual for a resolution to be accompanied by an explanatory note, but any resolution or amendment having financial consequences must be accompanied by a full explanation, with figures, of those consequences.

Resolutions and Amendments shall only be moved and seconded by either nominees on behalf of the Cabinet, or by registered Delegates on behalf of a Club, or two Clubs when a Resolution is sponsored by more than one Club.

Full details of the Social programme and the resolutions received will be circulated in due course, but meanwhile, it is very important that Club Presidents bring the Convention date to the early notice of their members and encourage as many as possible to attend.

Do not forget that it is your last Convention as District 105M, as we look forwards together to joining District 105CW from July 2019; let us do our best to make it a memorable one.
